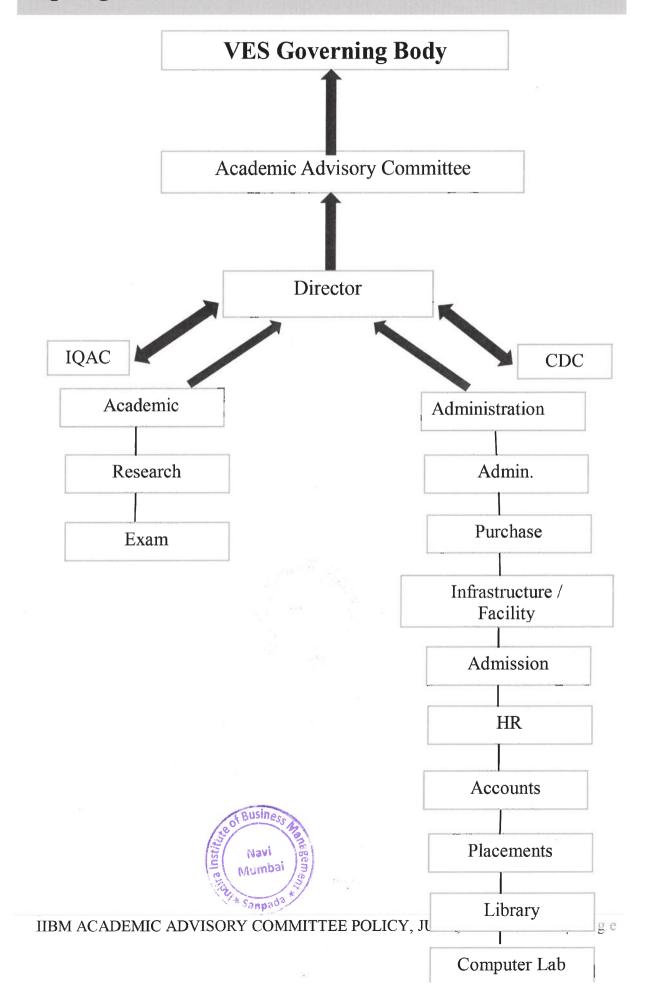

This IIBM Academic Advisory Committee / Council Policy document is tailored to ensure compliance with statutory bodies, enhance academic quality, and align with institutional goals for the Master of Management Studies (MMS) program, affiliated with the University of Mumbai and approved by the AICTE (All India Council for Technical Education).

#### **Section 1: Introduction**

The Academic Advisory Council (AAC) of IIBM serves as a strategic body to guide and strengthen the academic integrity, quality, and industry relevance of the MMS program. The AAC ensures that the curriculum, pedagogy, and academic processes align with the vision of IIBM, the guidelines of the University of Mumbai, and the norms set by AICTE.

#### **Section 2: Objectives**

- 1. To advise on curriculum design, delivery, and evaluation for academic excellence.
- 2. To ensure industry relevance and alignment with global management education trends.
- 3. To recommend measures for enhancing faculty development, research, and innovation.
- 4. To support accreditation and compliance requirements (AICTE, University of Mumbai, NAAC, NBA, etc.).
- 5. To foster collaborations with industry, academia, and professional bodies.

#### **Section 3: Composition of the Committee**

The AAC shall consist of distinguished members from academia, industry, and the institution. The composition will be as follows:

Designation	Role
Chairperson	President of VES Trust
Convenor	Member appointed by VES Trust
External Academic Experts (2)	Senior Professors from reputed institutions (preferably from AICTE-approved and/or NAAC/NBA accredited institutions) at the discretion of the VES Trust
Industry Experts (5)	Senior professionals from relevant sectors

Note: The AAC may invite additional experts as needed, from time to time.



#### e. Student Development

- 1. Advise on co-curricular and extra-curricular activities to enhance soft skills, leadership, and employability.
- 2. Support initiatives in innovation, entrepreneurship, and social responsibility.

#### **Section 6: Reporting and Documentation**

- 1. The AAC shall submit **meeting minutes** and an **annual report** to the VES Trust, which may later be cascaded down to the Director and the IQAC, if need be.
- 2. Recommendations will be reviewed by the internal body of Academic Council and incorporated subject to feasibility and statutory approvals.

#### Section 7: Renewal

This policy will be reviewed every **three years** or as needed based on changes in AICTE/University guidelines or academic requirements or on the decision of the President of the VES Trust.
